

enviro-cashback Application form

What is enviro-cashback?

The BP Solar enviro-cashback is a cashback offer paid to customers who install eligible solar electric systems using BP Solar modules. It is a combination of a manufacturers rebate (paid by BP Solar) and a payment for the value of the emissions savings (known as Renewable Energy Certificates or RECs). In exchange for any cashback, BP Solar will ask you to assign the rights to any RECs that you may be entitled to in accordance with Federal Government legislation, which BP Solar may use for emissions trading. You are under no obligation to assign the rights or accept the enviro-cashback offer, however it is only payable by BP Solar if the rights to your REC's are assigned to BP Solar. Please refer to the eligibility criteria below for further details. The enviro-cashback offer currently runs from 1st January 2007 to 30th June 2007 and is only payable on new solar modules/systems/installations incorporating BP Solar modules, sold and installed during this period. Enviro-cashback is subject to change without notice.

What is a Renewable Energy Certificate (REC)?

To encourage additional electricity generation from renewable energy sources, the Australian Federal Government, has set in place a scheme under which certain tradeable rights can be created for the generation of renewable energy or for the reduction of emissions of greenhouse gases. These rights include **Renewable Energy Certificates** under the Renewable Energy Electricity Act 2000 (Cth), NSW Greenhouse Abatement Certificates under the NSW Electricity Supply Amendment (Greenhouse Gas Emissions Reductions) Act 2002 (NSW) and rights under private contracts between parties. Solar electric systems like the one you have purchased can be eligible for creating RECs More detailed information on REC's can be found at http://www.orer.gov.au

The options for dealing with any RECs arising from this installation are:

- 1. Do nothing (this means the REC's have no value to anybody),
- 2. Create and use the REC's yourself, you may choose either 1, 5 or 15 year deeming in which case you will need to register with the Office of the Renewable Energy Regulator, pay the fees involved to register as a registered person to create them and then either keep them or find a purchaser for them; or
- 3. Assign the REC's to another party like BP Solar who will create the RECs.

In purchasing a solar electric system, BP Solar offers you the opportunity to elect option three (3) – that is, to assign the eligible RECs from this installation to BP Solar, in return for an 'enviro-cashback' on the price of the system which you have purchased, paid by BP Solar to you in the form of an Electronic Funds Transfer (EFT) to your bank account within **60 days** of receipt of your successful application.

Terms and Conditions of enviro-cashback

The following terms and conditions must be met to ensure eligibility for enviro-cashback:

- BP Solar enviro-cashback will pay: A\$0.50c/watt for assignment of RECs for 15 years.
- The program will run from 1st January 2007 to 30th June 2007.
- The applicant must be the legal owner of the system.
- The applicant has not and will not assign the RECs to any other party.
- The system must be sold, installed and commissioned in Australia, prior to applying.
- The installation must be signed off by the installer as being compliant with relevant Australian Standards.
- Enviro-cashback is only payable on new solar modules/systems/installations incorporating BP Solar modules, sold and installed between 1st January 2007 to 30th June 2007.
- A copy of your system invoice and solar module serial numbers must be provided.
- The system must be between 115 Watts and 100,000 Watts installed capacity.
- BP Solar's Enviro-cashback is only payable once per system, 15 year deeming, no additional rights are available to you.
- Applications for enviro-cashback must be made within 30 days of the system installation date
- BP Solar reserves to the right to decline any enviro-cashback application if any of the terms and conditions are not met, or if the system does not meet the relevant federal agencies legislation and guidelines for RECs.
- I agree that the Office of the Renewable Energy Regulator (ORER) and/or BP Solar or its appointed agent can inspect my system within the first five years of operation.
- I understand that there may be penalties applied for providing misleading information in this form under the Renewable Energy (Electricity) Act 2000.
- BP Solar reserves to right to amend or withdraw the offer at any time.
